- o Strike Mats will be used at all times, as it is now part of the SPN rule book.
- For Safety Reasons, a Bat Testing Machine was purchased a few years ago, and any suspect bats can be tested upon request. Bat rules are very strict, and are closely watched. The "Banned Bat list" has been updated with several bats added to it.
- Facebook postings and unsportsmanlike behavior. The league would like to get into the facebook world, but needs a way to filter out the unnecessary and unwanted content.
   Similarly, teams that have their own communication methods, are advised to keep it clean. Any unsportsmanlike behavior will not be tolerated.
- o Any SPN rule changes, will be reviewed, and communicated to the Team reps, if necessary.
